Open to all artists in the United States. Artists may enter up to 3 digital images. Work must be ORIGINAL SOFT pastels only. (No less than 80%). No oil pastels. No classroom or workshop work allowed. Paintings must be completed after January 1, 2007. **ALL PAINTINGS MUST BE FOR SALE.**

Entry:

Entry: Up to 3 Digital Images
Fee: PSNH Members - \$30
Non-Members - \$35
A 40% commission will be taken for all sold work.

Requirements:

Size Limit: Maximum 45" in any direction (including frame.)
Accepted work must be securely framed and ready to hang. If matted, neutral mats required on all accepted work. Painting must be identical to the accepted image.
Images of accepted work will be retained for PSNH archives.

Opening Reception:

Saturday, September 19, 2009 from 5 p.m. to 7 p.m. at Discover Portsmouth Center. Gallery hours are 10 a.m. to 5 p.m. 7 days a week.

DIGITAL IMAGE ENTRY PROCEDURE

All entries must be submitted on CD in .JPG format with a resolution of 300 dpi and images cropped to exclude mat or frame. CD must contain only the images intended for submission. All images on the CD must be saved as: **Artist Lastname_Title**. Print legibly on CD in permanent marker include: Name, Title, and HeightXWidth, including frame. Entry form and fee must accompany CD. Email submissions will not be accepted. **CDs will not be returned**
